JOINS US! NOVEMBER 18, 2025 MEMBER MEETING 7:00PM HELD VIA ZOOM Well it's the last newsletter of 2025! I wish everyone a safe and joyful holiday season. I would like to encourage anyone with interest to consider writing articles about your favorite dog sport, an impactful trial, event or training experience you had with your dog(s) that we can share in the newsletter in 2026. On that note...

I recently spent 2 days with my former Disaster Search and Rescue team from Washington at training weekend they held in Santa Paula, CA. These are the types of dogs that respond to disastrous events like 9/11, the fires in Maui, hurricane Katrina, the floods in Texas, etc. So it is an absolute privilege and honor to work with these dedicated dogs and handlers to make sure they are as prepared as possible when they get the call out to go saves lives or recover those lives lost.

And while the work they do is very serious and lives are at stake, there are many similarities to how these dogs are trained and the training for the sports that many of us do with our pet dogs. Understanding what motivates your dogs, understanding the things your dogs inherently likes to do (which is often significantly influenced by their breed), how they best learn, and most importantly how to reinforce the behaviors you want and knowing what types of rewards they like.

Even with the disaster SAR dog teams I was working with recently, knowing and understanding how to use a reward to reinforce a behavior is critical to getting the most out of training. And often owners are "rewarding" their dog but that reward might not be actually reinforcing the behavior they are intending.

So if you are training your dog and you are giving them a "reward" but you are not seeing an improvement in their behavior, your reward is likely actually not rewarding, and hence not reinforcing the behavior. Or there is not a clear path for the dog to understand what specifically they are being given a reward for.

So I encourage you all to routinely reevaluate just how motivated your dog is for the reward you have and how clear you are in communicating to your dog what they are being rewarded for. There are often small adjustments that can be made to increase the value f the reward without actually changing the reward itself. If you are using treats, what if you let your dog chase you to get the treat, what if you tossed the treat in the air for your dog to catch, what if you threw the treat for them to chase?

Play with your dog and experiment with a few of these things and see what gets them the most excited and motivated to work for the reward that you have. Happy training!



BOARD MEETING

The Board meeting was called to order by President Debra Lake at 6:30 p.m.

Minutes of the Last Meeting: The minutes from the September 16, 2025, Board meeting were approved as published. (Patty/Jill)

Report of the Treasurer: Jill said that Andrea just sent the attached Treasurer's Report, so nobody has had time to go over it, and there may be corrections necessary. She presented the attached report. All our events had a net income this year. Kurt is not getting the TR from Andrea – need to add him. Kurt suggested postponing approval of the TR until next meeting pending corrections, but it seems there are always corrections. Patty pointed out that equipment for one type of event was entered under Club Equipment instead of in the category of that particular event. Kris remembered a discussion in the past about this, when it was thought that all equipment should go in one separate category instead of with the event financial report because purchases could skew the profit/loss report on that event for that year, and then it wouldn't be accurate for looking back at the cost of putting on the event. Kurt suggested equipment should be amortized as capital expenses and be charged to the specific event. Suggestion to have equipment be a line item in the event report so it can be identified as not part of the expense of running the event. Suggestion to have equipment used only for one type of event charged to that event, and only equipment that can be used for multiple functions (like canopies) be categorized as club equipment. Michelle pointed out that if equipment purchases cause an event to lose money on paper, that could jeopardize the club wanting to offer that event in the future. No decision was made due to time constraints.
